Contestant Release Form

As consideration for being allowed to participate and/or compete in the Molalla Buckeroo Association Inc. (MBA) Donkey Race event. I, the undersigned, agree to the following:

Acknowledgment of Risk: The undersigned acknowledges that the MBA events are dangerous activities and that the participation in said events, as either a contestant, spectator, or volunteer, exposes the participant to a substantial and serious risk of property damage, personal injury or death. Each of the undersigned has observed events of the type that the undersigned seek to participate in. We further understand that the arena surface, access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to the participant. We further understand that other contestants and participants pose a danger to the participant, but nevertheless, WE EACH VOLUNTARILY ELECT TO ACCEPT ALL RISKS connected with entry into the restricted area and/or participation in any rodeo events. We assume all risks to ourselves, our guests and our children. The undersigned expressly acknowledges that his/her participation will involve such a hazard.

<u>Release:</u> The undersigned being fully aware that participation in the Donkey Race event will expose him/her to a substantial and serious risk of property damage and/or personal injury or death, hereby releases the MBA, stock contractor, and all sponsors from liability for any and all property damage, personal injuries or other claims arising from the undersigned's participation in said events including that are known and unknown, foreseen and unforeseen, future and contingent.

Covenant Not to Sue: In consideration for being permitted to participate in the Donkey Race and activities, we hereby agree to indemnify, hold harmless and release the MBA franchise, production entity or organization, their agents, representatives, sponsors, volunteers, owners, and stock contractors from liability for any and all property damage, personal injuries, death, or other claims arising from our child(s), our own, or our guest(s) participation in any MBA activity, including but not limited to, rodeos, practices, donkey race, or other activities, including claims that are known or unknown, foreseen or unforeseen, future or contingent. The undersigned covenants that the undersigned shall not now or at anytime in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the MBA or sponsors (or their officers, directors, employees, agents or affiliates) concerning, arising out of, or related to the actions, causes or action, claims and demands hereby waived, released or discharges by the undersigned. This release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law, if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Assurances: The undersigned has full power, authority, capacity and right without limitation to execute, deliver and perform this release.

Rules: The undersigned agrees to all the rules of the MBA donkey race.

<u>Binding Effect:</u> This release shall be binding upon the undersigned and the undersigned's spouse, legal representatives, heirs, successors, and assigns.

<u>Note:</u> Participants under 18 years of age must have the following signed by their parent or guardian. In submitting entry, contestant, parents and/or guardians agree to permit use of all publicity, photographs, radio and televisions broadcasts, motion pictures, newspaper and magazine accounts and websites.

<u>Consent to Treat:</u> I hereby give the EMT and the Molalla Buckeroo Association the right to treat the participant should the need arise.

EQUINE INHERENT RISK LAW: The Molalla Buckeroo Donkey Race and Molalla Buckeroo are subject to the Oregon State Equine Inherent Risk Law. ORS 30.687-30.697. By your presence at these activities, you have indicated that you have accepted the limits of liability resulting from inherent risks of Equine Activities. All participants, helpers and sponsors associated with the Molalla Buckeroo Association, will be regarded as participants and are limited by the inherent risk law.
